ORDER

Vide Note No 511-CS/2021 dated 15.05.2021 of Chief Secretary to the Government of West Bengal [copy enclosed] in respect of COVID vaccination in the State, it has been stated that:-

As per availability of vaccines, which is insufficient, the scarce vaccines available at the disposal of the Government of West Bengal may be divided into two streams, namely

i)General - For people at large: to be taken care of by the Health Department hospitals/CMOHS.

ii) Groups which are super-spreaders/public-facing/forcibly exposed to public mingling: groups which are endangered as well as potential spreaders to be handled by sectoral departments in conjunction with DMs.

The groups of persons who would be in the second category will include the following:

- a. Residuary segments (those who have not received COVID-19 vaccine earlier) of Government and para-Government employees including judicial staff who have not been vaccinated earlier.
- b. Dealers of essential services/ goods and their operating staff that is ration dealer, kerosene dealer and LPG dealers and petrol pump staff.
- c. Transport workers including taxi/Auto and toto drivers and rickshaw pullers
- d. Journalists



e. Lawyers and muharrirs, law clerks

f. Sex workers and transgenders

g. Hawkers including newspaper vendors

h. Retail sellers of vegetables/ grocery items/ fish etc. in bazaars

i. Covid volunteers

j. Inmates of social welfare homes and correctional homes

Now in pursuit of the above note and considering the evolving vaccine availability situation in the State and in view of the latest GoI guideline concerning expansion of intervals between two doses of Covishield , all Districts and KMC are hereby advised that-

Each and every Covid Vaccination Centre (CVC) within the jurisdiction of District/KMC shall henceforth, follow a systematic immunization drive. Local administration may like to work out innovative ways of scheduling the vaccination drives. Dividing days of the week between different age groups as well as separately scheduling/prioritizing first/second dose can be considered.

And all Districts and KMC are requested to chalk out an immediate plan to identify vaccinees belonging to the stipulated categories and start their vaccination at once. Detailed guidelines meant for guiding the Districts/KMC/Departments is being sent separately.

This approach shall be followed on all vaccination days until further intimation from this end.

<u>Sub:</u> Vaccination of residuary segments of Government and para-Government employees and approved priority groups

<u>Ref.</u>Guidelines Note of the Chief Secretary to the Government of West Bengal vide No 511-CS/2021 dated 15.05.2021 regarding COVID vaccination

Sir/Madam,

- 1. Apropos the above subject and reference and in terms of the decision taken in the State Executive Committee of the State Disaster Management Authority on 15.05.2021, following groups have been identified for vaccination:
 - a. General For public at large.
 - b. Groups which are super-spreaders/public-facing/fore public mingling/ groups which are endangered as well as potential spreaders --to be handled by sectoral departments in conjunction

[Detailed guidelines regarding their vaccination are enclosed in the attached sheet.]

- 2. It has been further decided that the aforesaid mentioned category of vaccinees will be further divided into
 - a. belonging to the age group 18-44 years and
 - b. 45 and above years of age



- 3. Those in the former group will be administered vaccine from the State's own procured stock and those above 45 years of age have to be administered vaccine from an earmarked separate stock under different CVC heads. This is for ensuring proper accounting of vaccines. Both the age groups will be covered either under separate workplace Covid Vaccination Centres(CVC) (which may be at the same physical location) or under normal health facility CVC.
- 4. Data regarding eligible employees/staff/other beneficiaries belonging to different categories mentioned in the guidelines may kindly be prepared as per the advice of the concerned department and kept ready at your end. A template in this regard is attached herewith.
- 5. I would like to further request you to kindly nominate one nodal officer from your district for the purpose of coordination in respect of database preparation and vaccination of eligible employees/staff/other beneficiaries as referred above.
